

# **LR Independent Assurance Statement**

Relating to Ingersoll Rand's GHG & EHS Data Calendar Year 2020

This Assurance Statement has been prepared for Ingersoll Rand Industrial U.S., Inc. (Ingersoll Rand) in accordance with our contract.

# **Terms of Engagement**

Lloyd's Register Quality Assurance, Inc. (LR) was commissioned by Ingersoll Rand to provide independent assurance of its Assertion for the Calendar Year 2020 against the assurance criteria below to a limited level of assurance and a materiality based on the verifier's professional judgment using LR's verification procedure for non-greenhouse gas (GHG) data and ISO 14064 - Part 3 for GHG data. LR's verification procedure is based on current best practise and is in accordance with ISAE 3000.

Our assurance engagement covered Ingersoll Rand's global operations and specifically the following requirements:

- Verifying conformance with:
  - World Resources Institute / World Business Council for Sustainable Development Greenhouse Gas Protocol: A corporate accounting and reporting standard, revised edition (otherwise referred to as the WRI/WBCSD GHG Protocol) for the GHG data<sup>1</sup>
- Evaluating the accuracy and reliability of data and information for only the selected indicators listed below:
  - Direct (Scope 1) and Energy Indirect (Scope 2) GHG emissions;
  - Energy use;
  - Water consumption;
  - Waste generated; and
  - Safety metrics.

Our assurance engagement excluded the data and information of Ingersoll Rand's suppliers, contractors and any third-parties mentioned in the report.

LR's responsibility is only to Ingersoll Rand. LR disclaims any liability or responsibility to others as explained in the end footnote. Ingersoll Rand' responsibility is for collecting, aggregating, analysing and presenting all the data and information within the Assertion and for maintaining effective internal controls over the systems from which the Assertion is derived. Ultimately, the Assertion has been approved by, and remains the responsibility of Ingersoll Rand.

#### **LR's Opinion**

Based on LR's approach nothing has come to our attention that would cause us to believe that Ingersoll Rand has not, in all material respects:

- Met the requirements of the criteria listed above; and
- Disclosed accurate and reliable performance data and information as summarized in Tables 1 and 2 below.

The opinion expressed is formed on the basis of a limited level of assurance<sup>2</sup> and at the materiality of the professional judgement of the verifier.

Limited assurance engagements focus on aggregated data rather than physically checking source data at sites. Consequently, the level of assurance obtained in a limited assurance engagement is lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.
